

BYLAW NO 2100-25

BEING A BYLAW OF THE CITY OF WETASKIWIN, IN THE PROVINCE OF ALBERTA, TO ESTABLISH RATES AND FEES FOR SERVICES PROVIDED BY THE CITY OF WETASKIWIN.

WHEREAS pursuant to section 7 of the *Municipal Government Act*, RSA 2000 Chapter M-26, a Council may pass bylaws for municipal purposes;

AND pursuant to section 8 of the *Municipal Government Act*, RSA 2000 Chapter M-26, a Council may pass bylaws for municipal purposes;

NOW THEREFORE under the authority of the *Municipal Government Act*, the Council of the City of Wetaskiwin, in the Province of Alberta, enacts as follows:

1. TITLE

- 1.1 This Bylaw may be cited as the *Fees and Charges Bylaw*.
- 1.2 That Schedules A, B, C, D, E, F, G, H, I, and J attached to and being part of the Fees and Charges Bylaw may be amended from year to year.

2. DEFINITIONS

- 2.1 In this bylaw:
 - a) **'Act'** means the *Municipal Government Act*, RSA 2000, Chapter M-26;
 - b) **'City'** means the municipal corporation of the City of Wetaskiwin;
 - c) **'City Manager'** means the Chief Administrative Officer of the City;
 - d) **'Council'** means the municipal Council of the City of Wetaskiwin;

3. INTERPRETATION AND APPLICATION

- 3.1 Without restricting any other power, duty or function granted by this Bylaw, the City Manager may:
 - a) Carry out any inspections to determine compliance with this Bylaw;
 - b) Take any steps or carry out any actions required to enforce this Bylaw;
 - c) Establish forms for the purposes of this Bylaw;
 - d) Establish reasonable criteria to be met for a room of facility to be rented including:
 - a. Possible security deposit requirement pursuant to this Bylaw;
 - b. Delegate any powers, duties or functions under this Bylaw to an employee of the City.

4. SEVERABILITY

- 4.1 If a court of competent jurisdiction should declare any section or subsection of this bylaw to be invalid, such section or subsection shall not be construed as having persuaded or

influenced Council to pass the remainder of the bylaw, and it is hereby declared that the remainder of the bylaw shall be valid and remain in force.

5. TRANSITION

- 5.1 This Bylaw shall repeal Bylaw No. 2073-24 and any amendments thereto on the date of final passing.
- 5.2 This bylaw shall come into full force and effect on January 1, 2026.
