



Solar Installation Grant Application Owner-Occupied Residential

This program has been specifically designed to give residential property owners access to grant funding to install solar panels on their property with the intent of lowering their power costs. **If you are a business or not-for-profit organization, including a landlord applying for a rental property you own, please use the Business/Not-For-Profit application form.**

Eligible applicants will receive **\$5,000** to install a **4kWh minimum** solar panel system on their residential property. Grant monies awarded may be used for both solar panel purchase and installation.

Please read the following before submitting your application:

Pre-Approval

- Submit this application to assess your eligibility for the Solar Installation Grant Program.
- The City of Wetaskiwin requires a quote for a **minimum 4kWh** solar panel system to be submitted with this application for pre-approval to be granted. **Applicants are strongly encouraged to seek more than one quote and to be cautious of installers going door-to-door using high-pressure sales tactics.**

Grant Approval & Payment

- An individual is only eligible to receive the grant once over the life of the program, even if they own multiple properties in Wetaskiwin.
- You or your installer must obtain a **development permit** (if applicable to your project), a **building permit**, and an **electrical permit** before proceeding with the installation of the solar panels. All permit applications must be submitted on or after Tuesday, **April 22, 2025**, for the project to be eligible for the grant. For more information on applying for and submitting permits, visit wetaskiwin.ca/developmentpermits.
- Before the grant is paid out, the City of Wetaskiwin will require **Permit Services Reports** (PSRs) documenting the final building and electrical permit inspections have been completed and the permit files are closed. The City will also require **documentation of the size of the installed system** (in kWh) and may request a copy of the Interconnection and Operating Agreement with Fortis if the installed size is not clear from the quote and permitting documents.



- The City reserves the right to request more details or send a City representative to view the system before payment is made.
- Payment will be made by cheque or EFT payable to the applicant as listed on the application form, or to the installer at the applicant's request. Payment to other parties will not be made.
- All fields in this application are required. Incomplete applications may not be considered.

Deadlines

- Solar panel installation and payment of the Solar Installation Grant must be done within eight (8) months of notification of pre-approval. In order to meet this deadline and ensure all available funding is allocated in a timely manner, applicants must submit all required permit applications within **four (4) months** of pre-approval.
- Extensions may be granted in cases in which the project has been initiated but will take longer than eight months to complete if proof is provided to the City of Wetaskiwin.
- If no proof is received that the project is underway, the grant monies may be awarded to another applicant.

Freedom of Information and Protection of Privacy (FOIP) Act Disclaimer

This personal information is being collected under the authority of Section 33(c) of the FOIP Act and will be used to administer funding under the Solar Installation Grant Program. All information gathered by the City of Wetaskiwin is protected by the provisions of the Act.

Failure to obtain consent from all mortgage lender(s) could result in the Participant breaching a mortgage obligation with the lender, and the City of Wetaskiwin and the donor are not responsible or liable for such an outcome.
8. If the property is in a building with shared facilities that the project will impact, I will obtain approval from the building owner or condominium board and provide it to the City of Wetaskiwin.
